

1) Approval of Minutes from May 2020

2) Maintenance Projects Outer Channel Navigation Improvements-Completed

6 Total: 5 Red (port) / 1 Green (starboard)



2) Maintenance Projects Dolphin Isle Dock Replacement- <u>Completed</u>

- The gangway remains in serviceable shape (replaced in 2017)
- ~ Total cost \$16,044 (includes installation)
- ~ 30+ year for useful life of new dock
 - North Lock docks are 14 yrs old and performing well






2) Maintenance Projects Calypso Shores Dock Replacement - Install 11/11/20


- The existing dock has reached the end of it's useful life
- The gangway remains in serviceable shape (replaced in 2017)
- ~ \$15,000 for removal, replacement and installation
- ~ 30+ year for useful life of new dock





2) Maintenance Projects North and South Lock Modernization

- Electrical failure at the South Lock prompted review of existing systems
 - Limit switches and wiring need to be replaced at each lock (12 at each)
 - Limit switches control the motion operations of the gates
- Scope of modernization includes:
 - Electrical system
 - Resident interface (key card access / integration with other BMKCSD key card access)
 - Elimination of operations flaws such as maintaining gate closure during extreme tidal differences
 - Estimates will drive schedule (likely 2022/2023)



3) Capital Projects in Planning: North Lagoon Dredge

North Lagoon Dredging

- Permitting at 80%
- DMMS: working with agencies on biological monitoring and vegetation removal to have site available in Sept. 2021
- Dredging locations

Dates

- Solicitation completed April 2020
- Contract awarded to Lind Marine (Petaluma)
- Construction: Sept Nov 2021

Costs

- DMMS Prep \$75k including soft costs
- Dredging Construction \$675k / Soft Costs ~75k


4) Administrative Overview


South levee

- SCC levee ownership request from the CSD Board – community outreach 2021
- Deferred levee maintenance and repair projects need funding to be undertaken

BMK V Updates

- The vast majority of the earthmoving work is complete
- Most of the equipment is no longer on site
- To be completed: The very ends of the new levee; the tie into the Novato Creek levee near BMK, and the tie into the N1 levee at the opposite end of the project. The work nearest Novato Creek began September 1
- This contract is nearing completion and anticipated to be substantially complete before Thanksgiving, weather permitting.

- A study was performed in 2019 with findings presented to the Board in 2020 for the purpose of ascertaining capital needs thru 2040 for marine and District owned assets
 - BMKCSD Board of Directors has commissioned an Ad-hoc subcommittee to study options for obtaining these additional funds
 - Measure D has been funding projects both maintenance / repair and capital needs since bond measure funds were expended thru a fiscal policy of spending and reserving Measure D annual funds received
 - However, additional funds must be obtained to preserve BMKCSD's marine assets beyond maintenance / repair budgets thru the Measure D parcel tax
 - Ad-hoc subcommittee recommendations anticipated to go to the full Board in 2021 with community outreach / education if recommendations move forward
