## VI. District Engineering Update on ongoing projects

A. North Lagoon Dredging

Board Directives to move project forward and pursue dredging permit for 2022 season

1. Proposal from WRA Environmental Consultant to perform a Special-Status Rail Survey The District Manager noted that a presence/absence survey would be required for the California Ridway's Rail in support of the work associated with the Novato Creek/lagoon dredge project. The survey would be in compliance with the avoidance and minimization Measure 2.12 in the projects Streambed Alteration Agreement form the California Department of Fish and Wildlife (CDFW). The survey would be performed between January 16<sup>th</sup> and at least Mid-March and all surveys would be a passive listening for the Rail. The survey would be required if the District intend to begin any site prep before September 1<sup>st</sup>. we would need to have the approval for the survey in tonight to begin work on February 1, 2022.

Vice-President Chase asked that clarification be made as to the reporting of requirements for each observation period.

- 3. Board Directive to authorize Foth to prepare and present a Tier 1 Exemption to the DMMO. In the event that a Tier 1 Exemption is not approved with the DMMO, Foth will present the findings to the Board for review and authorization of the next steps.
- 4. Board Directive to authorize Foth to initiate discussions with the SCC on availability and options to place material at BMK V as an option in lieu of the BMKCSD DMMS.
