A. LAFCO Municipal Service Review draft 2019 Update

Mr. Jason Fried, LAFCo executive Director, addressed the Board as to the changes that have been made after the mistake with regards to the annexation of the islands was corrected. He noted the comment period was extended to January 2020 and have already reviewed the comments received from BMK staff and new draft will be sent to out next week. He noted that there were three important items to clarify and as why there would be no annexation of Bel Marin Keys which include, Urban Growth Boundary which expires in 2030, given BMK's formation/government body to overlap services with the city and finally there is already expressed opposition for the annexation of BMK on record and LAFCo would not force annexation and not move forward without support of the residents. Mr. Fried continued to provide background as to what is required for LAFCo under its charter.

The Board thanked Mr. Fried for clarification and asked to be kept updated as to the final report.

A. Pacific Gas and Electric Transmission Tower Foundation Inspection in the Third Moat (Del Oro Intersection)

Were notified by PG&E that they are looking to inspect the tower on the third moat and work will require pumping water out of the moat and also closing the turning lane. They will need to submit for permits from the County for any of the work. We have asked that they notify us as soon as possible so we are able to notify residents and look at alternatives for possibly keeping the lane open as much as possible. They anticipate having work done in week.

The board asked to include emergency contact numbers for residents to reach out to PG&E, as well as, a safety plan and schedule that can be made available to residents.

The Board noted that we have been looking for a while to install a speed radar sign and will support the pilot program that in being undertaken by the County. The only suggestion is to move the radar sign from Calypso Shores and place it closure to the Montego intersection (i.e in front of Hudson Park) to capture the whole stretch of the Blvd not just the last section.
