Our established Standing Committees are another source of community pride. Our Measure G Committee has reviewed recommended wxpenditures and future project funding for Board approval in accordance with the required resident overisght.

Measure D Committee will be meeting later this month to provide a similar oversight of appropriate marine maintenace expenditures for Board approval.

Other ad Hoc Committees including the "Parks Committee", co-chaired by resident Natalia Shorten has established a mission of Equity Access to our parks and open space for all residents. We hope to provide lagoon access to all our non-lagoon residents in the near future. We have developed a concept plan to make Sunset Park a "swim beach" for residents only. The Parks Committee has requested the CSD to apply for and secure State Proposition 68 Grant money that which we applied for, but it required general public Access. The CSD chose not to accept the park Grant funding for our community and we will figure out a different funding approach.

The "Waterways Committee" whose mission is to improve the Operations, Safety and use of our waterways and regulations are working to update our regulations and most importantly, our education about how to use our waterways safely and WATCH YOUR WAKE -So as NOT to cause damage to boats docks and levees.

If anyone has any information on careless negligent boaters, please call the CSD office.

The "BMKCST" Bel Marin Keys Community Safety Team - Lead by Vice President Steve Nash, has been an amazing productiove team focused on community safety, PG&E upgrades, traffic safety, and ERT and Emergency preparation for any disaster. We finally have an ERT container

The "Grant Writing Committee" will be participating with the Novato Baylands Strategy Group to reach out for grants to restore our watershed and our lifeline to the Novato Creek.

The "Beautification Committee" lead by Cheryl Furst is making our community entry more inviting and sustainable by using native plants.

The "Welcome Committee" lead by Mercy Angelopulos is always there to welcome new residents and invite all residents to the Food Truck events in the CSD parking lot.

The newly formed "Communications Committee" headed by Chris Fehring and member Cheryl Furst are looking for ways to improve community communication with the website upgrade, social media, and public meetings.



MEASURE G OVERSIGHT COMMITTEE

The Measure G Oversight Committee consisting of 17 members from all areas of Bel Marin Keys had an initial meeting on August 22, 2024. We reviewed the Measure G finances and discussed next steps.

Marine Engineering firm SGH has been contracted to inspect both North and South locks, the flushing gates in the N. Lagoon, the connection pipe between lagoons, and the overflow structure in the South Lagoon. The locks electrical control systems, hydraulic systems, and gates were inspected by pumping the water out of the locks on August 22 and 23.

SGH will prepare a formal report describing maintenance required and prioritizing that work. They will also provide cost estimates and a list of contractors for the different tasks.



Measure A - Parks and Open Space Committee

Our Mission: "Providing equitable access for all BMK residents to enjoy all community amenities and stewardship of parks and open spaces"

Throughout multiple Town Halls held for Measure G, we received much feedback on ways to improve our community and thank you to all that attended and provided input! Now that we've passed that hurdle, it's time to get to work. With that feedback, we heard many creekside residents frustrated and seeking access to lagoons for swimming and kayaking. Therefore our "Measure A - Parks and Open Spaces Committee" that was formed from resident volunteers have aligned to make this a top priority within this committee and budget. No less of a priority however, we are stewards of our current parks and open spaces, and we will be taking actions as necessary to improve these areas as well.


There has not been any Measure G money allocated to parks or open spaces since priorities stand with replacing locks and other larger infrastructure projects. Park improvements will come from Measure A funds that have built up and will continue to receive yearly. These dollars can only be used for parks, and some money supplement may come from the operating budget on an as needed basis.

Our top priority project that the committee unanimously agreed upon, will be turning unused space at Sunset Park into a swimming and kayaking beach accessible to residents only. After reviewing all parks and open spaces this location serves as the best option, as it is a natural inlet away from boating, protected by wind, south sun exposure, under-utilized area, park frontage parking on BMK Blvd, centralized location to all residents, and has adequate

The conceptual design below includes:

- 1. Controlled resident card key access
- 2. Safe & accessible boardwalk
- 3. Shoreline revetment retaining wall
- 4. Fixed Dock
- 5. Sand beach area
- 6. Demarcated swim area
- 7. Buffer & separation from adjacent neighbor
- 8. Park frontage parking
- 9. Kayak storage

Conceptual designs and high level estimates were presented during August 22, 2024, CSD Board meeting where funding of \$150,000 from Measure A and a NTE of \$150,000 from CSD Operating Budget was unanimously approved. The committee also looked into supplementing through state grants but were not viable due to requiring public access which we do not support. We are seeking additional financial support through donations of money, volunteer time, or materials within our BMK community, Novato, or elsewhere.

A Walk-Through Time with Madeline Thomas: The Birth and Evolution of Bel Marin Keys

Stepping into Madeline Thomas' home on Montego Key is like entering a living time capsule, filled with memorabilia that tells the story of Bel Marin Keys (BMK) and its nautical community—a story that began in the 1960s. Born and raised in San Francisco, Madeline met her husband there, and they initially considered settling in Corte Madera. However, the rural charm of Bel Marin Keys, despite its dirt roads and cows, eventually captured their hearts. Initially homes on Montego Key started at \$25,000 in 1963, and they bought their home on Montego Key in 1964 for \$29,500 anchoring themselves in what would become a lifetime of adventure, boating, and community involvement.

Madeline and her husband were among the first residents of Stage I, when the homes on Montego Key were in the planning stages. Most new homeowners were boat enthusiasts, creating a community bound by a shared passion for the water. Many early residents were professionals who had the time and resources to volunteer their expertise in building the community.

The first homes were built on Montego Key, followed by those on the Boulevard and other streets. At that time, the lagoons were tidal, and residents had to navigate mindful of the tides. However, the construction of a private lock in 1974 transformed the waterways, making them safer and healthier for the community. Madeline recalls how cooperative the county was in bringing the project to fruition, thanks to detailed planning, financial projections, and the commitment of residents.

As the community grew, so did the need for additional infrastructure. Home Savings responded by developing more homes, which were sold through lotteries, with prices at \$245,000. Despite this growth, the decision not to expand into Unit 5 allowed the State of California to take the land for conservation, preserving Bel Marin Keys as the close-knit community it remains today.

The boating enthusiasts wasted no time founding the Bel Marin Keys Yacht Club in 1965, which quickly became the heart of social life. Events ranged from dockside gatherings to fishing and cookouts. Madeline fondly remembers a 4th of July fireworks display, launched by a Lucasfilm pyrotechnician—a spectacle that drew crowds until it was canceled for safety reasons.

Over the years, Madeline has observed a shift in the community's boating culture. In the early days, nearly every resident owned a boat and regularly ventured into San Pablo Bay. As home prices increased, the number of boat owners declined, but the community's dedication to maintaining the health of the water has remained strong. The Community Services District spends at least \$50,000 annually to maintain water quality, remove algae, and ensure a thriving aquatic environment.

As the original pioneers of Bel Marin Keys age, Madeline expresses concern about the declining levels of volunteerism among newer residents. She urges young families and newcomers to get involved in the many clubs and events that have defined the community's spirit for decades. "What we have here is gold," she says, calling on all residents to preserve this legacy by volunteering, joining clubs, and participating in the events that make Bel Marin Keys such a special place to live.



The BMKCSD Public Committee has been hard at work and planning our move in the emergency response team Conex box. You will notice there is a new Conex box in place at the entrance to BMK in the fenced in area, we also have a second Conex box which covers the north side of BMK Blvd. Both are prepared in case of a mass disaster. In addition, we have the CSD office and the BMK Community Center with emergency generator power. We also have emergency radio systems which have been recently upgraded to communicate with the County and within BMK.

We have also started planning with abilities to cook at the BMKCSD Club House for the community in case of a mass disaster. More will follow as we continue to develop this plan in order to protect the community if we have a mass disaster.


The video cameras at the entrance are being replaced, the current cameras were video only and the new cameras will read license plates as well as recognize vehicles that are wanted by law enforcement.

The Marin County Sheriff's dispatch will be directly alerted when it enters or exits Bel Marin Keys allowing the Dispatch to notify responding Deputies. This will help reduce crime by capturing the suspects, while they are in Bel Marin, Keys, community, instead of the crime being discovered when you discover it.

We hosted the BMK National Night Out which included the Sheriff, Sheriff's Office, The Sheriff's Office Search and Rescue, the Novato Fire Department the Marin County Health Department with NARCAN distribution as well as our County Board of Supervisor Eric Lucan. We had the food trucks attend additional night by being there for National Night Out.





SGH COMPLETED INSPECTION OF BMK LAGOON INFRASTRUCTURE

On 8/23/2024 SGH completed a week of engineering inspections of the North Lock, North Lagoon radial flushing gates, South Lock, South Lagoon overflow structure and levee, and the connector pipe between North and South Lagoons. This work was authorized by the BMK Board to determine what maintenance of these assets is required and help establish the priority for work. Their final report is expected in a couple of months and the Measure G Oversight Committee will review it and work with the Board to prioritize repairs. In preparation for lock maintenance, the CSD is receiving bids for stop logs to temporarily dam the North Lock so it can be dewatered for maintenance.



HAZARDOUS CHANNEL MARKER IN SAN PABLO BAY ENTRANCE TO BMK

Today, Brian Clark pushed the marker piling at the turn from Novato Creek towards the Petaluma River back up to the point where it will always be well above the water level and therefore not a hidden hazard to navigation. Brian Clark, Matt Glerum, and Terry Friesen went out to the subject mark and using the steel BMK workboat, Brian was able to push this piling from a nearly horizontal position, back up to a position where the top is at about +11 feet MLLW. As a result, it will always be well above the water level and easily visible. The piling is sound and was not broken off. It appeared to be pushed over by a heavy vessel, perhaps a barge from last summer's dredging. The workboat was not able to push the piling completely vertical because of interference with framework on the bow of the workboat.

New red and green marker signs will be ordered and installed for pilings where these signs are missing.
