- 1. The above recitals are true and correct.
- 2. A US Bank Platinum Business Checking Account and Platinum Business Money Market Account for Measure G funds.
- 3. Funds, designated solely for Measure G purposes, be deposited, transferred, and maintained in said account, reserved for such specific purposes.
- 4. When obligations are due for payment and there are sufficient funds in the account so designated to pay such obligations, the District Manager may cause payment thereof to be made from this account, and transfer funds between accounts to ensure sufficient funding.
